

Recycling of Metals for Crematories: Some Important Questions and Some Straightfoward Answers

The funeral home and crematory professions are ones that require a great deal of sensitivity, as you know, and the issue of the proper disposal of metal bio-waste is no exception. Being certain that post-cremation metals are handled properly has become an important issue, most notably in the past few years. I would like to offer some insight into the recycling process and at the same time answer some of the questions that I most commonly hear from you, the crematory operator.

1. Why bother with recycling at all?

As a crematory operator, you have a few choices on how to handle the metal---throw it in the garbage, bury it in the ground (believe it or not, I've actually heard that), or recycle it. As a concerned citizen, you doubtless realize that fewer precious metals need to be mined if already existing metals are available for reuse in the marketplace. As a businessperson, you also realize that some of these materials have a high intrinsic value (gold was trading near \$1,225 per troy ounce and palladium was trading near \$770 per troy ounce at the time of this writing). The issue for you is whether it is convenient and expedient for you to include recycling in your protocol.

Over the last two decades our society has become increasingly more educated about the negative environmental impact of putting heavy metals into the ground by way of landfills and garbage dumps. Doing so not only contaminates the soil and ground water, but is also against the law. Recycling has become less of an option and more of an expectation.

When referring to recycling, the term "repurpose" has become mainstream recently because it accurately describes the end result. The sectors that benefit the most from repurposing post-cremation metals are aerospace, military, automotive, medical and technology. From medical implants to circuit boards, all have a big impact on our day-to-day lives.

- 2. What are my choices regarding compensation? The choice of how to handle compensation is entirely yours. If you are not interested in compensation for the metal, you can always donate it. Many crematories like to actually publicize how much they were able to contribute to a local or national charity. When the families are informed that it really isn't practical for you to incorporate the retrieval of dental prosthetics, for instance, into your protocol, and that the best option for you is to work directly with a trade refiner to properly recycle the metal, they are usually sympathetic to this approach.
- 3. What are the relative values of the different post-cremation metals?

When I refer to "post-cremation metals," I am grouping together

everything you might encounter---including, but not limited to, dental prosthetics, joint replacements (most commonly hip and knee), back braces, and pacemakers. The major difference in these materials is value, which is predominantly contained in the dental material.

The materials in dental prosthetics range from "high noble" alloys (containing more than 60% gold/platinum group metals, or PGMs) to "noble" alloys (containing more than 25% gold/PGMs) to base-metal alloys (containing less than 25% gold/PGMs) to alloys that are non-precious altogether. There are literally hundreds of different dental alloys on the market. In contrast, the jewelry industry uses only a handful of standards (10, 14, 18, 22, and 24 karats) that are stamped on pieces of jewelry to indicate precise mixtures of gold, copper, zinc, and silver. Dental prosthetics are not marked in this way.

4. What about the value of the metals in implants? Virtually all of the metals you will encounter (precious and non-precious) will be classified as "native metals." These are any metal that is found in its metallic form either as pure or as an alloy, in nature. The hip and knee implants that you are likely encountering with increased frequency are made of titanium or chrome-cobalt alloys. These are classified as "high-temperature" or "refractory metals" because they are extraordinarily resistant to heat and wear. Because they are non-precious they have little monetary value and are significantly more cumbersome to deal with than dental material. These metals are widely used in industry as mentioned before so there is still a need to properly recycle them.

Because these low-grade implant metals melt at a much higher temperature than precious metals they should not be smelted together if it can be avoided. Additionally these metals are often highly resistant to homogeneously alloying with each other. The simplest way to avoid commingling these metals is to separate them by hand when putting cremains in your processor or by using a processing unit with a screen ahead of the funnel that catches small pieces. Separating out the dental material from the less valuable material in this way gives you a better handle on how much high-value material you are turning in for recycling.

5. Is it possible for anyone to "guesstimate" how much value there is in my dental material?

Trying to assess the value of dental material a crematory can generate simply on the basis of how many cremations are performed will yield only a very rough guide. Whatever you may have been told, it is not just difficult---it is impossible---to determine the value of dental material by simply looking at it.

As mentioned previously, there are hundreds of different dental alloys, and the only way to accurately evaluate the precious metal content of a collection of dental prosthetics is by putting it through a smelting and assaying process. Smelting the metal into a homogeneous bar allows proper sampling. Once there is a sample that is representative of the whole bar, that sample can be assayed to determine the precise elemental content. If any of the steps in this process is missed or done improperly, the results will necessarily be inaccurate.

6. Bearing all these facts in mind, what criteria should I use when choosing a recycling company?

I think there are three essential criteria to provide maximal peace of mind in a process that relies so heavily on trust. First, choose a recycler that has smelting and in-house assaying capabilities. Any so-called recycler who relies on ball-park estimates rather than solid scientific techniques is inherently troubling.

Second, choose a recycler that demonstrates complete transparency. Any recycler should be more than willing to allow you to visit the facility at any time, to witness the process, provide a sample from your melt for further verification and to answer any questions you might have. You deserve the level of confidence that approach will provide. Lastly, term agreements and/or FREE equipment are a red flag. How many of you have noticed gyms and cell phone companies are shifting away from long-term agreements and allowing you to function on a monthto-month basis? Previously, they would routinely lock you into agreements that were difficult to get out of if you were unhappy. If a company is willing to give you "free" equipment in return for your metal, it seems to muddle an otherwise simple transaction. It's also probably too good to be true. I have long subscribed to the theory that you should want to do business with a company, not feel obligated to.

I hope this has shed some light on the process of recycling and has answered some of the questions you may have had.



A Creative Touch: New flower shop opens in Bassett

BASSETT – "I said, 'God, I just need to get out of the house,'" said Shirley Amos. "It's like He opened the door and said, 'Well, here you go."

Four years ago, Amos, the manager at Riverview Flowers and Gifts, didn't think she'd ever reenter the world of floral arrangements, even though creating beautiful bouquets to send to members of the community was her passion.

"I ran my own florist in Bassett for 24 years," Amos said. "When my husband got sick with a brain tumor, I sold it."

While Amos wanted to care for the love of her life, she missed

the people she'd come to know over nearly a quarter century in the flower shop – even though she originally had no intentions of becoming a staple in her community in that way.

Virginia Funeral Directors Association Recruitment Incentive Program

Effective January 1, 2018 through December 31, 2018, you can receive \$250 dues rebate for every new member firm you sign up. Spread the word and earn some cash back!

Recruitment Incentive Program Rules

- 1. **Rebates.** Dues rebates are not transferable and not exchangeable.
- 2. Eligibility and Limitations. Participants must be a VFDA Member Firm in good standing through December 31, 2018. A limit of four (4) rebates may be paid to a firm member. Any member recruiting more than four (4) new members will earn \$250 payable to the recruiting members district. Any new member firm must remain a member in good standing for one year from the time they are approved for membership and membership dues are paid in full in order for the rebate to be credited. Newly recruited members must sign up as a member firm in order for the recruitment incentive to be awarded.
- 3. Taxes. Recruitment incentives are considered dues rebates and not taxable income, and \$1,000 or the total amount of the recruiting member's annual dues, whichever is less.

 Members will not receive an IRS Form 1099 from VFDA. Districts receiving rebates are expressly prohibited from transferring any portion of those funds to the recruiting member.
- 4. Exclusions. Members of VFDA Board of Directors and standing special committee chairs, as defined by the Bylaws of the Association, are not eligible for the individual recruitment incentive if the board member or committee chair recruits a new member while on travel being reimbursed by the Association.
- 5. Forms Submission and Deadline. In order to be considered, a Member Firm who recruits another Member Firm must notify the VFDA office prior to the December 31, 2018 deadline. A completed and signed Member Firm application, must be approved by the VFDA Board of Directors by the December 31, 2018 deadline. Applications must be submitted electronically by scanning and e-mailing them to info@vfda.net, or by fax at 804-264-3260. Completed and signed forms MUST be RECEIVED prior to the deadline. Membership application form is available for download and printing at www.vfda.net
- **6. Payouts.** The Association Treasurer will pay out individual recruitment incentive rebates via check no later than January 1, 2019.





VFDA Legislation for the 2018 Legislative Session

(And other legislation filed by House and Senate Members)

EDRS: As we reported in our last newsletter that our lobbyists, Julia Hammond and Angie Bezik, have reached out to the lobbyists for two hospice associations. Matt Cobb of Williams Mullen represents Virginia Association for Home Care and Hospice and Becky Bowers Lanier represents Virginia Association for Hospices.

Julia and Angie have continued to reach out to Mr. Cobb and Mrs. Lanier; however, after an initially positive meeting, Matt and Becky have not been responsive to multiple attempts to continue dialogue. We should expect that the legislation VFDA supports as its lone 2018 Legislative Agenda item will meet some pushback from these organizations.

Delegate Tony Wilt has stepped up once again to be a champion for VFDA by agreeing to be our patron. Senator John Cosgrove, who has also always been supportive has agreed to patron the same bill in the They are HB1158 and Senate. (Due to a glitch in SB309. Legislative Services, SB309 was drafted as another piece of legislation and will be corrected either by an Amendment in the Nature of a Substitute (the right language for the entire bill in place of this language) or by striking SB309 and using one of the extra slots for legislation that Senator Cosgrove has available.

The legislation will require that hospice service provides who accept Medicaid to fund their services must require their physicians to register and use the EDRS to file/sign death certificates.

Other legislation that has been filed includes a good news/bad news component. The good news is that VFDA members are reaching out to their legislators! The good news is that their legislators are listening! Based on outreach by Oakey Funeral Home to Delegate Head, legislation was filed with the intent to urge physicians to use EDRS. The not so good news is that Delegate Head's creative thinking ends up allowing physicians to opt out of EDRS. Outreach to Delegate Head's office was received warmly by his Legislative Aide, and our lobbyists will be meeting with Delegate Head personally to discuss. We appreciate so much Delegate Head's efforts to assist the use of EDRS by all.

Senator Jennifer McClellan has filed, by request, legislation (SB357) that would require mandatory use of EDRS. We of course support that, but to date, such legislation has met strong opposition from the Medical Society of Virginia.

There are also bills that establish Overdose Death Review Teams, which could possibly include funeral directors as members of the statewide and local teams.

SOCIAL SECURITY ADMINISTRATION:

Julia and Angie have reached out several times to the Social Security Administration for their direct assistance in support of our hospice legislation. They have been non-committal to date, but have agreed to talk in person about it now that the holidays are over, and they are available to meet. It is our hope that they will either draft something official or speak to the need to increase the number of EDRS users.

New Committee Make Up in the House: Due to the election outcomes and the drastically different margin of majority, the makeup of the committees must change. Our legislation typically goes to Health, Welfare and Institutions; however, sometimes we end up in Commerce and Labor, Courts, or Appropriations.
