

#### **C&L** Containers continues with next generation

CHESAPEAKE, VA-- In 1991, after the closing of his family's business, Tidewater Produce, Matt Russo was approached by longtime family friend, Jimmy King, of Fallon Body Removal Service. Jimmy expressed the need for a company on the East Coast that could manufacture shipping and cremation containers.

After researching the industry, Matt approached his brother in-law, Isaac Williams, with his idea. They became partners and founded Custom Air Trays in 1992. #### Thacker Completes Multimillion-Dollar Investment to Expand its U.S. Manufacturing Capabilities

Thacker Caskets recently completed a multimillion-dollar investment project at its casket manufacturing facility in Florence, Alabama. Over the last 3 years, Thacker built the newest casket shell stamping facility in the United States. To house its new stamping operation, Thacker added a 40,000 square foot building, making Thacker's total manufacturing facility nearly 340,000 square feet. The new building, equipment and dies will offer Thacker customers new and innovative product improvements that no other manufacturer offers.

It has always been a dream of the Thacker family to own and operate its own casket stamping facility as it allows for complete control of the manufacturing process from beginning to end.

CJ Thacker, CEO of Thacker Caskets said, "with the new stamping facility complete, there is no other casket company in the US that controls more casket and component manufacturing capabilities under one roof than Thacker." He went on to say, "As corporate manufacturers continue to increase prices to appease Wall Street investors, we are investing back into our business to develop new and innovative products to help funeral homes - all at an honest price."

In designing the dies that would physically form the various casket components, Thacker insisted on thinking outside the box (pardon the pun). Rather than replicating what every other manufacturer already had, Thacker incorporated several new features into the dies.

All Thacker 20-gauge, 20-gauge non-gasketed and 18-gauge caskets now feature a curved design on the bottom base rail and a more modern lid profile that accentuates the beauty of the metal itself. Thacker is also the only manufacturer to include a fully stapled interior attachment system directly within the stampings, to ensure a consistent interior fit and finish.

While the dies were being engineered Thacker also developed Tailored Designs<sup>TM</sup>, the industry's only interior attachment system that allows for funeral homes to change the interior fabric of the casket on an at-need basis. Tailored Designs<sup>TM</sup> was launched in 2017 and has given countless families the ability to choose an alternative interior from Thacker's unique line of eight modern fabrics. Without the creation of the brand new dies, this project would not have been possible.



#### **JULY 2019 LEGISLATIVE UPDATE**

#### PRIMARIES ARE OVER

June 11 has come and gone, and party primary elections are over. The following is a brief rundown of what happened across the state with hyper-links to some graphics that VPAP.org developed regarding the results. We will also share some information about November's general election.

Overall, there were 33 primary contests in General Assembly districts around Virginia. That includes 19 contests in the House of Delegates and 14 in the Virginia Senate. Of note, there were twice as many contests on the Democratic side (22) as there were on the Republican side (11). The nominating elections were a mixture of races involving challenges to sitting incumbents, races to determine the nominee who will challenge an incumbent from the opposing party in November, and races to win the party nomination in seats being vacated by departing legislators. In several contests, the power of incumbency was on display when just three sitting legislators from either party lost an election. (Delegate Bob Thomas and Senator Rosalyn Dance, and ultimately Delegate Chris Peace conceded on June 28.).

There were many interesting contests. For instance, long-time incumbents being challenged, such as Senator Dick Saslaw (D-Fairfax) and Senator Emmett Hanger (R-Rockingham). As also mentioned above, long-serving Delegate Chris Peace (R-Hanover) ultimately conceded to Scott Wyatt on June 28<sup>th</sup> after much intra-party struggle. However, by far, the most interesting "plot twist" was the defeat of incumbent Senator Rosalyn Dance (D-Petersburg) race, who was unseated by Joe Morrissey. Morrissey, a former member of the House of Delegates and a past Richmond Commonwealth's Attorney, is perhaps best known for his aggressive style and many personal controversies while serving in the House of Delegates.

Another special note of interest: candidates for the House of Delegates this year are presently running in districts whose boundaries have been adjusted by a federal court ruling. As a result of that ruling a district map drawn by Republicans in 2011 has been replaced with a map created by a political science professor at the University of California-Irvine.



#### LEGISLATIVE CHAIR MESSAGE



I can't believe we are already halfway through 2019. So many good things happened this year during the 2019 legislative session for the VFDA and now it's time to refocus for the 2020 session.

I want to extend a HUGE congratulations to Jerry Andrews and wish him the best! I look forward to this year with you as our president.

I also want to congratulate Larry Spiaggi for his year as president! It was a great year and I look forward to working hand in hand with you again this year on legislation!

Now on to the matter at hand, EDRS. I want to remind you again to keep after these doctors and getting signed up. We are still working with doctors who are not aware of the new changes so the letter from the VFDA and the information sheet are still as important as ever. We see the light at the end of the tunnel approaching. Let's just hope it's the end of the tunnel and not some unforeseen freight train! Either way, your continued efforts are working and we will get to full operation by the end of the year.

Our focus again this year is going to be the Next of Kin Law. We are working with the Virginia Bar Association. At this time, we are waiting on them to finish their updates. It was at their request that we pulled this legislation during the 2019 session and now we have partnered with them to make it even better. We feel like this cooperative effort is going to further strengthen this law and make it better for funeral homes when an issue does arise, but more importantly, make this law better for the families we serve. Last year we faced some opposition from the other two funeral associations in Virginia. They both feel like the current law is easier. Perhaps it is easier. But there are far too many loop holes in this law. And no immunity protection from funeral homes when we deal directly with immediate family members; only when dealing with non-family members.

There are a few points I want to address in regard to the current law. Larry and I have spoken at great length with Scott Gilligan, General Counsel for the NFDA about this law. He feels that Virginia is greatly lacking, much like we do. So much so that he put together a six point outline which details what areas need to be addressed. This outline will be available on the VFDA website (www.vfda.net) for your review. I want to focus on the points he makes in his review. One area that seems to be the biggest sticking point between associations is the priority order, or lack thereof in Virginia. Did you know that Virginia is the ONLY state which does not have some sort of priority order in place? Additionally, if the person who would be the one responsible for making arrangements does not wish to do so, the VFDA offers a release of liability and an acceptance of liability form to be signed. This form then allows whoever is willing to accept the responsibility of decision making as well as bear the expenses of said arrangements to be in charge. The priority order is the one single area where we cannot agree upon between associations to make this law happen. To our membership, and this committee, that is a necessary part. When the lawyer for the NFDA tells you in no uncertain terms your law is lacking, especially in that area...it's high time we listen.

Scott Gilligan also breaks down these other five points Virginia is missing. No majority control when it comes to decision making. Recently a firm in Virginia called him to ask what to do to settle a dispute. Three children were at his arrangement table, two wanted cremation, and the remaining child did not. If both are willing and able to pay the bill for their desired method of disposition who wins? Well the answer is nobody. Everyone, including the funeral home loses. The next point, is who is responsible to search for any additional legal next of kin. With the proposed law, the responsibility falls solely with the family members. The funeral home may also take a written statement from family members at face value and use that as their means to proceed. The only time a funeral home would have to do any kind of investigation on their own is if no family comes forward to make disposition arrangements. All that being said, in our current law we do not have to search for anyone since there is no priority order. Where that issue becomes very murky is when you have a relative who steps forward such as a brother to make arrangements for his sister. But is the funeral home obligated to tell her husband (if she has one) or any other surviving relative? And what if the brother instructs the funeral home not to tell her husband or surviving relatives? All these questions are cleared up with the new changes.

Each and every funeral director in his/her career has served a family where a divorce is pending. This situation can be very touchy. Who do you listen to? Children? Spouse? Siblings? Again, much like above, this law clarifies what happens. When a divorce is pending, the spouse loses his/her right of disposition. Then following the priority order we propose, disposition would then fall to the closest living next of kin. When charges for murder are pending, the person who is charged with the crime would also be exempt from making disposition arrangements. Also in this case, the closest living next of kin would then be responsible for disposition arrangements.

In Virginia, one area that has been addressed to a point, is when remains are unclaimed following death. In 54.1-2807.2, a funeral home can take direction from a person of no relation who is willing to identify the body and assume all expenses for disposition. Virginia also has 32.1-309.2 which allows the highest law enforcement officer in your county to authorize disposition with a court order. This is helpful as it is now, and our only real option. With this change in the law, we would have a clear and concise method to follow with less red tape and bureaucracy to achieve final disposition.

Lastly, as I mentioned earlier, Virginia's current law does not offer any kind of immunity. That means that if an incident occurs, the funeral home, each member of your staff (i.e. manager of record, the funeral service licensee, the crematory manager, the crematory operator) involved, a third party crematory (if your business uses a third party) can and will be included in a law suit. This immunity clause is a major protection from people who see funeral homes as a soft target. Or perhaps your local "hearse chasing" lawyer. Mistakes are always going to happen. And as a business you will have to deal with those. But someone who didn't get their way, should not have the ability to take you to court and drag your good name through the mud in a fit of anger.

I know this article is somewhat lengthy. But this law must be addressed this year. It is worrisome to me when we choose what is easy over what is best for our profession. The families we serve, and their litigious nature are continually changing and in turn, making our job more and more difficult. While there are going to be times when we have to wait for arrangements to be made, isn't it simpler to slow things down than to bear the expense of a lawsuit and the tarnishing of your funeral home reputation? We are aware that it may create a situation that requires a day or two of waiting so that uncertainties can be addressed. But as a rule, we will now have a backbone as a profession as to what is and what isn't allowed. Again, we as businesspeople, pay for and trust professionals to give us advice. Why would we not listen to the advice of the general counsel of the NFDA, who is the preeminent expert on litigation in the funeral profession?







#### Funeral Rule to Undergo Federal Trade Commission Review; Input Wanted

The Funeral Rule, enforced by the Federal Trade Commission (FTC), is set to undergo a review process later this year, according to Patti Poss, a senior attorney for the commission's Bureau of Consumer Protection.

A consumer protection rule created in 1984, the Funeral Rule requires funeral businesses to give consumers accurate, itemized price information and other disclosures about goods and services offered. The FTC reviews this rule every 10 years to ensure that it stays current and relevant as the industry evolves.

Although a concrete date for the review to begin as yet to be determined, it is likely to look at the role of technology in the funeral profession and if online price lists should be included in the rule.

"[The review] informs the commission," Poss said. "All kinds of market participants can comment and review. That's what we like when we send out these notices is to get feedback and information about what's going on with the rule and how it's working."

One way to prepare for the upcoming review is to consider what changes have occurred in your own funeral business in the past decade. Are there things that make complying with the Funeral Rule easier or more difficult? Poss says to expect basic questions like that when the review process begins.

"The only way I can think of [the review process] affecting funeral homes, for now, would be if they want to provide input," Poss said. "It's hard to make a decision unless we have a lot of information from all people who are affected by the rule."

The FTC will publish information about the Funeral Rule review process when it begins on its website (www.ftc.gov) and through the Federal Register – the daily journal of the Federal government. Until then, funeral homes may download the current compliance guide or order bulk paper copies for free online.



Before his first shift as a part-time employee at Henderson Funeral Home, F. Keith Francis was concerned because he didn't have a suit. He had sport coats and ties but no suit.

"That's fine," replied Ronald Wagner, owner of the business. "Just watch what we do."

So Francis watched Wagner and his team at the time. He watched them care for grieving families through acts of compassion and kindness. He watched them treat each person they encountered with fairness and respect. He watched them take their work seriously but not at the expense of their personalities.
