# How to Limit Staffing Issues at Your Funeral Home

Earlier this year on the industry news source Funeral Director Daily, Tom Anderson wrote about staffing issues some funeral homes are facing due to culture shifts, changing technologies and a shrinking pool of qualified applicants.

The Bureau of Labor Statistics estimates a 4% growth in the profession from 2018-2028. That combined with an aging population of 76 million baby boomers in America, the industry will likely see changes and challenges in the years to come.

Arizona, North Carolina and Vermont have passed or are looking to pass bills that modify the regulations for funeral licensing to prevent staffing shortages and to help those moving to the states find gainful employment in the industry quickly.

So how can you prevent gaps in your team? Hire people you don't know.

Samuel Rhue, interim director for the funeral services program at John Tyler Community College, says enrollment in the program is healthy and includes an increasing number of students coming in with no immediate ties or family connections to a funeral home. They are purely interested in the profession, and those students have a difficult time finding internships and employment opportunities after graduation.

He also said the program consists of more female students than ever before and that most of his students would simply ask for a chance to prove themselves – an opportunity to "come in and show what they can do and to be open to change."

If you aren't looking to fill positions in the immediate future, other ways to prepare for a potential shortage of staff include considering flexible working hours and flexible on-call schedules, partnering with neighboring homes to cover shortages if they arise, and talking to your current team to resolve any pain points they experience in their day-to-day work.





Good Day members. As we continue through the Fall, I just wanted to update you on a couple of things happening with the legislative committee. This committee is working constantly behind the scenes and listening to the voices of our membership. Sometimes we are unable to make things happen as quickly as we would like, but working with government...well you know the rest.

I want to talk briefly about the progress in the EDRS. Some of you are finding great success with doctors and their willingness to learn and use the system. Others are still meeting with resistance. Again, I want to remind you that you do have the ability to file a complaint of unprofessional conduct against the doctors who won't use the system. Be patient with those who are willing to use and learn the EDRS, and if possible take the time to teach them.

The Next of Kin bill we have been working on for the past two years is still being worked out, but we have agreed mostly to what the new proposed law will look like. We still need to iron out some details of exactly how it will be written, but it seems like we have something that can pass the General Assembly. More details of that will follow.

The VFDA is also looking to partner with the two other funeral associations in Virginia, as well as the Virginia Bar Association, to better inform lawyers of how the designee law works. This is of great benefit to both the consumer, and the funeral profession. Obviously this is not a new law in Virginia, but there are many lawyers and even funeral directors who are unaware of how it works. So we are going to put our heads together on how to work with lawyers across Virginia to better implement a designee agreement when they are working to establish wills and trusts.

Lastly, we are in the early research portion of how to increase the law that allows funeral homes to take a death certificate to a bank to receive payment towards a funeral bill. Currently the cap for that is \$4,000. We are going to research what some others states who have similar laws allow for.

As always, we are open to suggestions! There is a fair chance that if something has happened to you, it has or will happen to another funeral director. We want to take those ideas and suggestions to better see if we can address them. Some may not require legislation, but this committee would act on your behalf.




