

#### Meeting Career Goals with New Dual Licensing Initiative

What kind of impact can a funeral director really have on someone? For Joseph Teets, funeral directors changed the course of his career.

In 1992, Teets attended his first funeral—a memorial service for his great-grandmother—and the directors in charge of the service went above and beyond to take care of his family and make sure everyone felt comfortable and supported while grieving their loss.

Now, thanks to the dual licensing initiative for Virginia, he has the opportunity to follow in the footsteps of the funeral directors from his past and serve grieving families in his own community.



Dual licensing in Virginia allows individuals to apply for either a Funeral Service License, Funeral Director License, or Embalmer License. This flexibility gives future funeral service professionals the option to pursue specific career goals or make tangible progress in their journey to earning their full Funeral Service License.

"After speaking with the Board of Funeral Directors & Embalmers about possible paths to licensing before my internship license expired, I decided the Funeral Director License was the best route for me to meet my goal of helping families," Teets said.

"Now that I've passed my Arts exam, I can serve families as a funeral director and give back to my community while I continue to prepare and train for the Science exam."

This license is the latest addition to his education and certifications which include an Associate of Applied Science degree in Funeral Service (earned with honors) from John Tyler Community College and a Bachelor of Science in Elementary Education and a master's degree in teaching from Liberty University.

Since earning his Funeral Director License in March, Teets has joined the staff at Horne Funeral Service in Christiansburg, Virginia.

"Dual licensing made it possible for me to get to where I am in my career today. For me, I don't think it's a bad thing to allow people to choose the route that works best for their interests and goals."

#### NFDA Launches National Emerging Leaders Program

The National Funeral Directors Association (NFDA) launched the National Emerging Leaders Program on April 12 to help funeral service professionals develop leadership skills that will serve them well in any setting they may find themselves – their funeral home, their state or national association, their community, and beyond.

"The National Emerging Leaders Program will help developing professionals who will one day carry the torch in our profession, our businesses and our communities cultivate the skills necessary to lead with integrity," said NFDA President R. Bryant Hightower Jr., CFSP. "Helping funeral professionals build sustainable businesses and become pillars in their communities is an integral part of NFDA's mission and this program will go a long way toward developing future leaders."

The NFDA National Emerging Leadership Program is open to all licensed funeral professionals, regardless of NFDA membership, from the United States and Canada who are still early in their careers (first-career funeral directors licensed 5-10 years or second-career funeral directors licensed 3-8 years).

This year-long program for 20 select individuals will start and end at the 2021 and 2022 NFDA Leadership Conferences (the 2021 NFDA Leadership Conference is scheduled for August 1-4 in Charleston, South Carolina; 2022 dates will be announced later this year). In addition to meeting during the Leadership Conference, participants will meet virtually approximately eight times throughout the year to learn from experts, both from within the profession and from outside authorities.

The program features a practical and theoretical approach to advanced leadership topics. The curriculum, which is being developed in partnership with an expert consultant in leadership development, will cover topics such as mentorship, ethical leadership, employee relations, collaborative decision–making, strategic planning, servant leadership,

communication skills, small business ownership, and more.

Participants will also have access to mentors, engage in high-level networking, and work with fellow program participants on a group project that will teach them to apply the skills they are learning in real-world scenarios.

The National Emerging Leadership Program requires an investment of \$1,500, which includes the registration fee for the 2021 and 2022 NFDA Leadership Conferences; approximately eight virtual sessions led by quality speakers and trainers; printed educational materials; CE hours; high-level networking with leaders in the funeral profession; and more. Participants will also receive up to a \$1,000 travel stipend to cover their travel and accommodations (i.e., airfare, hotel, meals) for the 2021 and 2022 Leadership Conferences.

Preliminary information about the NFDA National Emerging Leaders Program is available on the NFDA website, www.nfda.org/emergingleaders. Additional details, including information on how to apply for the program will be available on April 12. Applications are due May 15. Selected participants will be announced in early June.



#### FEMA COVID-19 Funeral Assistance What You Need to Know and How You Can Help

Individuals who incurred funeral expenses due to a COVID-19 related death after January 20, 2020, can now receive up to \$9,000 per funeral in reimbursement funds from the Federal Emergency Management Agency (FEMA). This reimbursement plan is part of the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 and the American Rescue Plan Act of 2021 approved by Congress.

The application process, which opened on April 12, 2021, is managed strictly by FEMA and can only be initiated through a telephone hotline. Calls take about 20 minutes and applicants must provide documentation before being approved.

While funeral directors are not responsible for providing application assistance nor are they able to apply on behalf of a client or family, they can take an active role in educating their communities about this new assistance.



#### What You Need to Know

To qualify for reimbursement, applicants must be able to provide documentation that the death of their loved one occurred in the United States after January 20, 2020, with COVID-19 being listed as a cause of death. Phrases like "may have been caused by" or "was likely a result of" COVID-19 or COVID-19-like symptoms are considered sufficient.

They must also provide proof of funeral expenses that include the applicant's name, the name of the deceased, the amount of the expense, and that those expenses were incurred after January 20, 2020.

Individuals may apply for reimbursement more than once if they are responsible for the funeral expenses of multiple deaths attributed to COVID-19. They can receive up to \$9,000 per funeral with a maximum of \$35,500 per application per state. If multiple parties paid for funeral expenses, they must apply for reimbursement using the same application.

Funeral expenses that qualify for reimbursement include but are not limited to transportation for up to two individuals to identify the deceased, transfer of remains, casket or urn, burial plot or cremation niche, marker or headstone, clergy or officiant services, ceremony arrangement, use of funeral home equipment or staff, cremation or interment costs, and costs associated with producing and certifying multiple death certificates.

Pre-planned, pre-arranged and pre-paid funerals along with any source of payment made in anticipation of a future death are not eligible for reimbursement under this assistance.

#### How You Can Help

Funeral directors are not tasked with administering application assistance. Businesses are also strictly prohibited from applying, so funeral homes and firms cannot apply to receive reimbursement for outstanding bills or fees owed. But advocacy and education can help grieving families across the state feel confident and at peace with the way they choose to honor their loved ones.

Now that applications are open, your firm can reach out to families you served over the past year and make them aware of the FEMA Funeral Reimbursement. You can also run ads in your local newspapers, on local radio, and share information on social media about this program.

Other ways you can step in and provide assistance include providing multiple copies of the documentation individuals will need if they wish to apply and helping families walk through the process of amending death certificates if needed to meet the minimal requirements for funding.

The FEMA Funeral Reimbursement program is open at least until 2025, with uncapped funds at the time of press to cover funeral expenses of any COVID-19 related death in the United States. This means a family who may not have been able to have the memorial service they truly wanted in the height of the lockdown can plan one at a later date, when they feel safe to do so, and still be eligible to receive this reimbursement. It also means that families who may be on a strict budget may have more margin to plan the funeral they want versus one they have to settle for due to funding.

Funeral service professionals are a key resource for helping share about this important program and having at least one colleague available to field calls and questions about the dos and don'ts of the application process would be highly beneficial to both your firm and your community.

Additionally, the National Funeral Directors Association created a FEMA COVID-19 Funeral Assistance toolkit for its members that includes a customizable press release for local media, print newspaper ads, social media graphics, a conversation guide for directors, template letters to send to families and more. You can access it with your log in credentials online.
