





#### **OCTOBER 2016 LEGISLATIVE UPDATE**

#### **Pre-2017 Legislative Session Update!**

VFDA worked hard this past legislative session to achieve a number of items that would be beneficial to the funeral director profession. What we were able to secure was passage of legislation clarifying and denoting specific data can be changed on death certificates via affidavit vs. court order and budget language requiring the Virginia Department of Health/Vital Records to file a report with the Chairmen of the House Appropriations and Senate Finance Committees by October 1, 2016. The language in the budget stated, "The Department of Health shall report on efforts to address changes to the Electronic Death Registry System that would improve the system to make it easier for filing death certificates, address interoperability concerns by users and provide technical assistance to system users, and other improvements. The department shall report to the Chairmen of the House Appropriations and Senate Finance Committees by October 1, 2016."

At the October 11, 2016 EDRS Stakeholder Meeting, (formed as the direct result of the budget language), Debbie Condrey said that the report had been drafted and submitted to Commissioner Marissa Levine for her approval. Ms. Condrey said that until the time that it is approved, it is considered to be the "Governor's Confidential Working Papers," and she cannot release the report to us. She stated that the general layout of the report includes background on the issue, including stakeholders; that EDRS was created to be a voluntary use program; the challenges Vital Records has been made aware of; what is being done to address the challenges; the future of EDRS, including a recent NCHS grant; the financial information on original startup – allocated dollars and actual dollars as well as staff time used to create the program. She indicated that she will release the report for our review as soon as it is approved.

Vital Records has documented their efforts to address "the list" that VFDA compiled from stakeholders and has put them in a PowerPoint document. Debbie Condrey has asked that VFDA circulate the PowerPoint with the note that efforts are continuing, and it is a "living document," subject to changes as they occur. That document will be posted to the VFDA website for your review – it is too large to include here.

There are a couple of notable updates. The first is the interoperability/interchangeability of username and password for the Prescription Monitoring and license renewal for health care provider programs. It was determined that because VDH uses third-party venders, they will be unable to connect automatic registration of EDRS to these programs. However, Vital Records has received a grant and has begun a statewide plan to educate heath care providers and launch with stakeholders (emergency physicians, family physicians, physician assistants, nurse practitioners, hospitals, etc...).

One of the concerns of VFDA members has been the compatibility of various browsers used to access the EDRS portal/information. Vital Records has started on this project and are working on the Internet Explorer 9-11 with "compatibility mode," and working to make Internet Explorer 11 fully compatible (without compatibility mode). They are also working on Chrome, Safari and Edge. There are plenty of other updates, please go to the VFDA website for more.

As mentioned previously, Vital Records applied for and received a grant from Centers for Disease Control and Prevention (CDC) and National Center for Health Statistics (NCHS). The grant was awarded for a two-year performance period running through April 15, 2018. In that time, Vital Records *must* register at least 80% of deaths electronically through EDRS; train stakeholders and market the EDRS (including establishing an EDRS Stakeholders' User Group – already done!); participate in stakeholders' conferences and meetings; as well as develop web browser enhancements. They will be hiring three new people to do the statewide training and marketing of the EDRS. A PowerPoint detailing the grant called "Division of Vital Records Business Updates" will be posted to the VFDA website.

The VFDA Legislative Committee and Board of Directors have established the 2017 Legislative Agenda. Julia and Angie will be working diligently to secure patrons and move efforts forward. The items are:

- ✓ Mandating use of EDRS by State Medical Colleges (UVA & MCV)
- ✓ Streamlining court ordered changes to death certificates via Clerks of Court
- ✓ Allowing filing of death certificates at any Local Health Department

We have had a number of active members and hope that more VFDA members engage on the legislative front. Thank you all for what you do for the needs of your profession. Julia and Angie love working with VFDA and look forward to engaging more members to facilitate the outcomes on behalf of your profession. Please make sure to come to Richmond for VFDA Legislative Day.

#### **ELECTIONS**

Election Day was November 8. VFDA hopes all of its members participated in the electoral process. In Virginia, besides the Presidential and some Congressional seats, we had a couple of special elections for the General Assembly. Following Election Day, we may have a few more special elections. The Virginia House of Delegates will have their election November 2017 along with Governor, Lt. Governor and Attorney General. The House and The Virginia Senate will all be up for elections again in November 2019.

In the Senate, currently two seats are open. Former Senator (Now Mayor of Norfolk) Kenny Alexander's seat is open. Delegate Lionell Spruill (D), is the lone candidate for the VA Senate – 5<sup>th</sup> District Seat. Senator John Miller passed away in April of this year leaving VA Senate District 1 open. There are three candidates, Delegate Monty Mason (D), John Bloom (Contitution Party), and Thomas Holston (R), with Delegate Mason the likely winner.

There may be two Virginia Senate seats vacated due to Congressional races. Senator Donald McEachin (D) and Senator Tom Garrett (R) are each running for Congressional District 4 and 5 respectively. Each are likely winners for those seats.

The House of Delegates will have special elections as well, due to this November's elections. Delegate Scott Taylor (R) vied and won the primary against longtime 4<sup>th</sup> Congressional District Representative Randy Forbes for the 2<sup>nd</sup> Congressional District seat being vacated by Congressman Scott Rigell. He is running against newcomer Ms. Shaun Brown (D). Taylor is the likely win. This will leave Taylor's Virginia House District 85 open. Currently Norman "Rocky" Holcomb (R) and Cheryl Turpin (D) have each filed to run for this seat.

Delegate Ron Villanueva (R), has had Independent, Bill Haley, file against him for the 21<sup>st</sup> House District race. Haley ran against Senator John Cosgrove for the Senate District 14 seat last year.




