

WHAT'S THAT THING DO ANYWAY?

QR CODE or QUICK RESPONSE CODE is a two-dimensional matrix barcode that is readable with a QR reader or smart phone. They've been used in Japan for years and are now becoming increasingly more commonplace in the U.S., and should be considered for your funeral home.

They're everywhere, from print-ads, direct mail and instore signage to television and billboards, QR codes were the hot buzz-word for marketers in 2011. Can OR codes offer businesses (and your funeral home) real advantages or are they just the latest fad? According to the American Marketing

Association, strategic marketing firm Russell Herder recently

conducted an online survey of over 500 U.S. residents to gain awareness levels of QR codes and attitudes toward their use among consumers. The results? The research study, "The QR Question: Are QR Codes an Effective Marketing Tool for Engaging Customers," suggests that a

substantial number of consumers demonstrate lack of understanding as to what QR codes are or how they work. But don't scrap them just yet! Marketers have a penchant for pronouncing the death of the latest trend or technology too soon. They said it first with email, which we all continue to use daily.

Did you know Google will make them for you for FREE? All you have to do is visit http://goo.gl - their URL shortener. Once you have entered the email address you would like to shorten, click on "details" it will automatically create a QR code for you that you can save on your computer for later use. Although there are dozens of free QR code creation websites out there, Google is a stable company which will most likely be around for a longtime to come. Because it's free why not try it when placing your next print advertisement; what do you have to lose?

I've Created My QR Code...Now What?

Test it! Test it on the computer screen as well as print it off and test it with an iPhone, Blackberry and Android device. According to Robin Heppell, CFSP, founder of FuneralFuturist.com the following are a few ways funeral homes can use QR Codes: online obituaries, directions to your funeral home, a cemetery, or reception hall; direct mail; business cards, and print ads just to name a few.

Disaster Response Teams: Notes & Rebuilding

Report from I. Ray Sloan, FSL, DRT Chief Coordinator, DRT Chairman

he VFDA Disaster Response Team was contacted last spring to be involved in a FAA required triannual training event at the Roanoke Regional Airport. We were involved in meetings and conference calls up until the day of the event, September 29, 2012. The scenario consisted of a MD-80 ingesting a large bird shortly after take-off, crashing into a field northwest of the airport. "Mountain Flight" carried 123 souls. After the initial response of fire and rescue, we responded with the OCME team to recover over 35 "deceased" victims. The OCME Staff consisted of Dr. Bush, Dr. Gormley, Dr. Benson, Rochelle Altholz, and a response team of over 30 technicians and investigators. Duffy Ferguson of Oakey's Funeral Service and I, along with Rick Sikon of the Anatomical Board, transported these "Victims" from the scene to the temporary morgue located in Building 31 of the airport complex. The OCME had set-up the storage racking system, the new MRC Unit (a portable cooling system), decedent trackers, intake desk, two pathology suites, and x-ray station.



Everything went well with the exercise. A few problems were noted and will be taken care of. The problems included documentation of transport for chain of custody issues from the scene to the morgue, and having separate entrances/exits to the morgue area and storage area. The cooperation of all involved was very evident and appreciated.



The Disaster Response Team is rebuilding itself to conform with new regulations of being able to be activated with the OCME teams. As far as we know, to become credentialed and be able to respond, one has to contact the local Medical Reserve Corps in your area (http://www.vdh.state.va.us/mrc), then express your interest in being trained as a OCME volunteer to your MRC coordinator, and take an OCME orientation class. Then, through the OCME, we will be taking Morgue Operations, Dental, and X-Ray classes. After that you will be assigned to the closet OCME location.

As we set up our new team format, I will need seven deputy coordinators from each of our districts, four OCME district coordinators, and four teams of members that will assist their local OCME district offices. In case of an event, I, as chief coordinator, and Executive Director Lacy Whittaker will be called then we will issue a call out of available team members. Please remember this is a volunteer group of concerned funeral directors that will serve as needed. I am proud of the fact that during our recent mass casualty exercise at Virginia Western Community College in Roanoke, I contacted six local funeral homes and was able to provide (theoretically) the OCME with seventeen transport vehicles and twenty four funeral home staff members, of which I was very proud of our association's firm members working together



N avigating Your Lease In today's economy more and more people are renting instead of owning their homes. Both tenants and landlords have certain rights and obligations. Reviewing the lease:

- Is there a noise ordinance?
- Are there any rules on guests or subleasing?
- What responsibility does the tenant have for lawn care and landscaping?
- How much notice are tenants required to give before vacating the rental property?

Be proactive. Have an attorney review any lease agreement before you sign.
